13 Boland and West Coast Competitions -Boland: Feedback from EXCO meeting by LM: -more games should be played on a 2 ball Trips and 3 ball pairs basis as this is the new trend here and overseas. - No indication yet from Boland when inter district trials will commence. LM to enquire -LM to call on all clubs to now start identifying their Mens, Ladies and Veteran players via their selection committees and with the aid of coaches, who can afterwards assist the players with special coaching.
