

WEST COAST DISTRICT BOWLS Minutes of the Inaugural Meeting 25 August 2016

1. Call to Order

A West Coast District Bowls inaugural meeting was held on 25 August 2016 at Velddrif Bowls Clubhouse. It began at 15h00 and was presided over by Leon Meyer, with Gail Lotz as secretary.

3. SASCOC:

Leon shared with those present a brief background about SASCOC (South African Sports Confederation and Olympic Committee).

- Structure for sport in South Africa
- Divided South Africa into 10 provinces we are in Western Cape Province Sports Council which was then divided into 6 Districts
 - o Cape Town Metropole
 - o Cape Winelands
 - Central Karoo
 - o Eden
 - o Overberg
 - West Coast
- Each district has its own sports council

4. West Coast Bowls:

It was discussed by Leon that in order for West Coast Bowls to be established various criteria need to be in place. Therefore, this meeting is held in order to pass the West Coast Constitution and form a full West Coast Executive Committee.

He shared that Stoffel Lambrecht had kindly completed a generic constitution for all the districts.

Bowls South Africa was contacted and they were in favour of the changes being made within Boland. However they did stipulate the importance of all three (new) districts playing under the Boland 'umbrella' at Inter-district tournaments.

Leon informed all present that with the formation of the West Coast District Bowls entity it would be necessary for an annual AGM to be held and office bearers to be elected.

Finance - the West Coast District will be able to apply for finance for development purposes.

5. Moving Forward

Tournaments being held in the West Coast to date:

- West Coast Snr League, has been held annually for the past 12 years.
- West Coast League has been held annually for the past 6years.

Leon shared an idea which he asked those present to think about and get back to him about it – a one hour game, 10 ends, being played in 4's format.

6. West Coast Colours:

Leon informed all present of the colours of the West Coast Bowls District. They are powder blue; red and white.

7. Signing of the Constitution:

Leon requested the signing of the constitution and asked if there were any queries re the constitution.

- Basie Louw ask if the new portfolio, Transformation and Female had been added to the constitution. Leon informed him that it had.
- Gail Lotz Queried the wearing of West Coast District colours as this was not stipulated in the constitution – perhaps it would be added to the by-laws?

All were in favour of the constitution being signed and this was then done by Leon Meyer and Gail Lotz.

8. Executive Committee:

Leon informed that with two persons nominated, there would need to be a vote for vice president – this was done.

9. Other:

- Affiliation remains the same affiliation fees to Boland Bowls and Bowls South Africa.
- Dudley from Porterville shared that they were pleased to inform all that Porterville Bowls
 Club had 18 new members from the prison services. Leon informed him that they would try
 and send coaches to assist the coaching of these new members.
- Parker queried re: paying of affiliation fees. He was informed by Al Cannone that the ruling from BSA was that if you play on an affiliated green you are liable for Boland and BSA affiliation fees. Leon informed all that Joggie had worked it out that bowling fees worked out to be R13 per month!
- o Headquarters for West Coast Bowls District was decided upon to be Velddrif Bowling Club.
- Adriaan Hubach queried that Boland Bowls affiliation fees were to be paid by October. He
 had always felt it was November. He was informed that it is October as stipulated in the
 constitution.
- Adriaan Hubach queried Malmesbury being part of Western Province and not Boland. Leon informed him that the same applied to Stellenbosch – they have chosen to be Western Province.
- Peter Welensky queried recognition for coaching and technical officials, this had been discussed and passed at Boland AGM but has never been implemented. He felt strongly that this should be implemented. Leon to investigate.

10. Adjournment:

Leon Meyer thanked Velddrif for hosting the meeting and moved that the meeting be adjourned, this was agreed upon at 15h55.
